






Pathways










FIGURE 12: CORELOGIC V22.1 AAL / \$1M TIV FOR SELECTED SCENARIOS



Prop. 33 marked the third attempt by Michael Weinstein and the AIDS Healthcare Foundation (AHF) to repeal the Costa-Hawkins Rental Housing Act and reintroduce radical rent control policies like those implemented in the 1970s and 1980s.

Prop 33: Justice for Renters Act

- Current Vote Status (as of Nov. 12):
 - Opposed: 60.6%
 - Supported: 39.4%
 - Ballots Tallied: ~10 million


MLS CORRECTION BUTTON



Compliance Department Actions:

- If no MLS violation, the correction submission is closed.
- If there is an MLS violation, a warning email is sent, allowing 3 days for correction.
- **If not corrected**, a citation will be issued (\$\$).

CCAR is accommodating if users cannot immediately comply; however, users must respond to warnings and coordinate with CCAR on specific issues and deadlines to avoid penalties.

SELMs

MLS Rules & Regulations, Section 7.5:

Mandatory Submission

Must submit within 2 days after all necessary sellers' signatures are obtained, or at beginning date of listing as specified in contract (whichever is later) on any exclusive right to sell/seller reserved listing on 1- to 4-unit residential property/vacant lots located within the Broker Participant's MLS service area.

Broker Participants shall:

- 1. Input the listing, or
- 2. Submit a seller-signed exclusion in accordance with Section 7.6 (Expt. Listings).

MLS Rules & Regs.



HINT!

Double the amount of time it will take to be ready for market. If you or your client believe it will require 30 days, list "60 days or sooner" on the SELM.



HOT TOPICS

Clear Cooperation

Submit within 1 business day of marketing a property to the public. The listing broker must submit the listing for cooperation with other MLS participants. Public marketing includes, but is not limited to: flyers in windows, yard signs, digital marketing on public-facing websites, brokerage website displays (including IDX and VOW), digital communications, email blasts, multi-brokerage listing networks, and any applications available to the public.

The public is defined as anyone outside the broker(s) and agent(s) licensed within a single listing brokerage and their clients.
